Services offered by the Legal Aid Council

NOTE: Every person who is detained or remanded at a police station lockup whether charged or not, may be granted legal aid. Once you have asked the police to contact a Duty Counsel on your behalf, they should wait until Counsel arrives before questioning you.

The Legal Aid Council enlist various Attorneys to assist individuals with criminal matters. The services offered are listed below:

<u>Duty Counsel</u>: A Duty Counsel is an Attorney-at-Law who will:

 Among other things, visit the location an individual is being detained or arrested and give legal advice, attend identification parades, make a bail application and attend the first Court hearing.

<u>Court Representation:</u> The assigned Attorney-at-Law will:

 Appear before the court on an individual's behalf, on or after the first court hearing date and represent that said person up until the conclusion of the trial proceedings.

NOTE: All services provided by the Attorneys empaneled by the Legal Aid Council are free. Terms and condition apply.

1. Can I get an Attorney from the Legal Aid Council to represent me in a Family, Land, or Civil? Unfortunately, the Legal Aid Council is currently authorized to provide/assign representation (an Attorney) for only criminal matters. Therefore, an attorney cannot be assigned for land, family or any other civil matter. The Council, through the Legal Officers on the Mobile Unit, provide legal advice and information in relation to civil matters and any other legal matter.

2. Do I need an Attorney to represent me in Court?

Generally, it is always highly recommended that an individual seek to retain an attorney or apply for legal aid to represent him/her during court proceedings as an Attorney is equipped with the requisite expertise and experience to handle matters before the Court. However, where persons are unrepresented, Judges have a duty to assist them in presenting their case to the Courts.

- 3. How do I become the registered owner of the Land I now occupy?
 - To become the owner of a piece of land, you must be registered on the title as the owner at National Land Agency (NLA). There are four ways an individual can have his or her name registered as a land owner at NLA, namely Transmission of Land Application, Transfer of Land Application, Adverse Possession Application and First Registration Application. All the applications involve various legal principles, for more information please contact an Attorney-at-Law, the Legal Aid Council or NLA.
- 4. How do I get a Divorce?

To obtain a Divorce an individual would need to file a document in the Supreme Court called a Petition for Dissolution of Marriage, to initiate divorce proceedings. Thereafter a series of documents are required to be filed and court appearances may be required depending on the circumstances. Due to legal complexity of the proceedings, it its highly recommended that the whole divorce process is handled by an Attorney-at-Law.

5. How do I get an expungement?

Expungement is done by way of an application to the Ministry of Justice. It is recommended that a person first contact the Legal Aid Council or the Ministry of Justice for more information. Note it is important to ascertain whether the conviction against an individual can be expunged as well as the procedure for the application.

Outreach

In January 2017 the Legal Aid Council's launched the Mobile Justice Unit, a project instituted to provide free legal advice and information to persons in targeted communities across Jamaica. The Council has continued to keep a steady presence in communities across Jamaica, while providing legal advice to an average of 70 persons each month.

The Mobile Justice Unit operated by the Legal Aid Council under the aegis of the Ministry of Justice visits at least seventy-two (72) Restorative Justice Centres and communities island wide yearly. The Mobile Justice Unit has continued to bridge the accessibility gap to justice services islandwide.
